He also holds a Master of Arts degree in Political Science from the University of Rhode Island, and a B.A. in Political Science, *cum laude*, from Providence College. He is admitted to practice in state and federal courts in Rhode Island and Massachusetts. Mr. Lamoureux is also admitted to practice before the U.S. Supreme Court.
